**NOTIFICATION**

No. Ele. (GP)01/17/ 1124 /SEC – Whereas, election to Ward Members and Sarpanches of Muktapasi Gram Panchayat and Patharakhamba Gram Panchayat under Parjang Block in Dhenkanal district was excluded from Commissions Notification No 5150 dtd.27.12.2016 vide Commission's Notification No.250 dtd.04.01.2017 as per the interim orders of the Hon'ble High Court of Orissa in W.P. (C) No. 21405 of 2016;

Whereas, in the mean time the Hon'ble High Court of Orissa in Order No. 5 dtd.16.01.2017 in Misc Case No 454/2017 & 19646/2016 have vacated the interim stay order;

Whereas, Collector, Dhenkanal vide letter No.120 dtd.18.01.2017 has reported to hold election of Ward Members and Sarpanches of Muktapasi Gram Panchayat and Patharakhamba Gram Panchayat under Parjang Block;

Now, therefore, in exercise of powers conferred under Article 243-K of the Constitution of India and Rule 13 read with Rule 18, 47 &75 of the Odisha Grama Panchayat Election Rules, 1965 the State Election Commission hereby appoints the following dates & time with respect to the said elections and matter of bifurcation of the Gram Panchayat involving Parjang Block shall remain subject to the result of the writ petition No 21405 of 2016.


The model code of conduct issued by the Commission will remain in force from this date i.e. **19.01.2017** till **21.02.2017**.


