
No. Ele. (GP)01/17/ 250 /SEC - Whereas, State Election Commission, Odisha has issued Notifications to elect Ward Members, Sarpanches of the State wide Notifications No.5150 dtd.27.12.2016;

Whereas, Collector, Dhenkanal vide letter No. 1959 dtd.31.12.2016 reported that Hon'ble High Court, Orissa has granted stay of operation of Order dtd.25.11.2016 in Misc. case No. 19646 of 2016 arising out of W.P. (C) No. 21405 of 2016 on the inclusion of Kamarda village which was a part of Muktapasi GP and subsequently tagged with newly created Patharakhamba GP;

Now, the State Election Commission, Odisha, therefore, in exercise of its power conferred under Article 243-K of the Constitution of India and other enabling powers in that behalf hereby exclude the election of Ward Member and Sarpanch of Patharakhamba and Muktapasi Gram Panchayat under Parjang Block in Dhenkanal district.


