## NOTIFICATION

No. Ele. (GP)01/17/3946 /SEC – Whereas, State Election Commission, Odisha has issued Notification to elect Panchayat Samiti Members of the State wide Notification No 5164 dtd.27.12.2016 excluding Panchayat Samiti Members of Parjang Panchayat Samiti of Dhenkanal district, Kolabira Panchayat Samiti of Jharsuguda district, Bhawanipatna Panchayat Samiti of Kalahandi district and Rengali Panchayat Samiti of Sambalpur district as per the interim orders of the Hon'ble High Court of Orissa in W.P. (C) No. 16152,16465,17247,20601 and 17362 of 2016 respectively;

Whereas, in the mean time the Hon'ble High Court of Orissa in Order No10 and 12 all dtd.25.01.2017 have vacated the interim stay order;

The model code of conduct issued by the Commission will remain in force from this date i.e. **14.03.2017 till 19.04.2017** in the concerned Panchayat Samities.


