Now, therefore, the State Election Commission, Odisha, in exercise of power conferred under Article 243-K of the Constitution of India and other enabling powers under Odisha Gram Panchayat Act, 1964 and Odisha Gram Panchayat Election Rules, 1965 is pleased to order that fresh election in respect of the office of Ward Member and Sarpanch mentioned in the statement where election was countermanded shall be held as per the following programme.

1. The model code of conduct issued by the Commission will remain in force from this date i.e. **14.03.2017** till **19.04.2017** in the concerned ward/ Gram Panchayat.



The nomination of contesting candidates except the deceased whose name have been published u/r 32(3) on the previous occasion i.e on 19.01.2017 during last General Election to PRIs, 2017 shall remain valid. They shall not file nominations again and they shall be intimated about the election schedule.

3. Withdrawal of candidature is only permissible for those candidates who are going to file nomination during this period.

4. Allotment of symbol shall be done afresh in Odia alphabetical order.


