

Whereas, Collector, Nuapada vide letter No. 21 dtd.06.01.2017 reported that Hon'ble High Court, Orissa has granted stay of operation of Order dtd.07.12.2016 in Misc. case No. 19646 of 2016 arising out of W.P. (C) No. 21402 of 2016 on the abolition of Latkanpada newly created GP out of Kurumpuri GP ( old) in Komna-02 Zilla Parishad Constituency under Komna Block in Nuapada district;

Now, the State Election Commission, Odisha, therefore, in exercise of its power conferred under Article 243-K of the Constitution of India and other enabling powers in that behalf hereby exclude the election of Ward Members, Sarpanch and Panchayat Samiti Member of Kurumpuri GP and Zilla Parishad Member of 02-Komna Zilla Parishad Constituency of Nuapada Zilla Parishad.


