Case No 3693/17 arising out of W.P.(C). No 4300/17 and dtd 10.03.2017 in Misc Case No 3746/2017 arising out of W.P.(C) No 4357/17 of the Hon'ble High Court of Orissa respectively;

Whereas, in the mean time the Hon'ble High Court of Orissa in Order dtd 10.04.2017 in W.P.(C). No 4300/17 and dtd 30.03.2017 in W.P.(C) No 4357/17 dtd.16.01.2017 have vacated the interim stay order;

## ORDER




