(GP)01/17/ **523** /SEC - Whereas, State Election Commission, Odisha has issued Notification to elect Panchayat Samiti Members of the State wide Notification No 5164 dtd.27.12.2016 excluding Panchayat Samiti Members of Dasarathpur Panchayat Samiti of Jajpur district as per the interim orders of the Hon'ble High Court of Orissa in W.P. (C) No. 15614 of 2016 and 16151 of 2016;

Whereas, in the mean time the Hon'ble High Court of Orissa in Order No. 7 and 14 all dtd.09.01.2017 have vacated the interim stay order;


