(GP)01/16/5332 /SEC - Whereas, State Election Commission, Odisha has issued Notifications to elect Ward Members, Sarpanches, Panchayat Samiti Member and Zilla Parishad Members of the State along with above posts of Dhamnagar Block in Bhadrak district vide Notifications No.5150, 5164 & 5178 all dtd.27.12.2017;


Whereas, in the mean time Govt, in Housing and Urban Development Department, have constituted Dhamnagar NAC vide Notification No.29975 dtd.23.12.2016;

Whereas, Panchayati Raj Department in their letter No.24732 dtd.27.12.2016 and Collector, Bhadrak in their letter No. 1051 dtd.29.12.2016, have reported that Dhamnagar NAC consists of full of Dhamnagar GP, full of Joyanagar GP and one village Talapada of Radhaballavpur GP of Dhamnagar Block and Collector, Bhadrak has furnished fresh reservation list for Ward Member, Sarpanch, Samiti Member and Zilla Parishad Member and has further reported that there is no need to hold PRIs election in respect of above Gram Panchayats/ Village;

Now, the State Election Commission, Odisha, therefore, in exercise of its power conferred under Article 243-K of the Constitution of India and other enabling powers in that behalf hereby exclude the election of Ward Member and Sarpanch, Panchayat Samiti Member and Zilla Parishad Member of the above Gram Panchayats and Wards which constitute Dhamnagar NAC.


