ORDER

No. Ele. (GP)01/17/ /SEC Whereas, Khalipathar Gram Panchayat under Belpada Block in Balangir District was created out of Juba Gram Panchayat vide notification No.11605 dtd.05.07.2016 of Panchayati Raj Department;

Whereas, Hon'ble High Court of Orissa vide Order dtd.02.02.2017 in W.P. (C) No.21265 of 2016 set aside that part of notification No.11605 dtd.05.07.2016 of Panchayati Raj Department on creation of Khalipathara Gram Panchayat out of Juba Gram Panchayat under Belpada Block in Balangir District;

Whereas the election of Ward Members, Sarpanch, Panchayat Samiti Member and Zilla Parishad Member of Khalipathara and Juba Gram Panchayat under Belpada block under 26-Belpada Zilla Parishad Constituency was cancelled during General Election to PRIs,2017 vide Commission's order No 2241 dtd 09.02.2017;

Whereas, the Collector, Balangir vide his letter No 1205 dtd 15.07.2017 has submitted the final list of Delimitation of Wards and Reservation of seats for Ward Members, Sarpanch and Panchayat Samiti Member after abolition of the erstwhile Khalipathar Gram Panchayat and merging the same in Juba Gram Panchayat;

Whereas the Electoral Roll prepared for the erstwhile Khalipathar Gram Panchayat and Juba Gram Panchayat can not be utilized for holding election and needs to be prepared afresh as per the Delimitation of Wards finally published on 15.07.2017;

Whereas, it is necessary to prepare Ward-wise Electoral Roll for Juba Gram Panchayat under Belpada Block on the basis of Electoral Roll finally published by the District on 25.11.2016 with 01.11.2016 as qualifying date for holding election;


Whereas the Electoral Roll published on 25.11.2016 will be split Ward wise inviting Objections and Claims for corrections and **no new claims for enrolment shall be entertained.**

Now, therefore, the State Election Commission, in exercise of powers vested in it by virtue of Article 243-K of the Constitution of India read with relevant

provision of Odisha Zilla Parishad Act, 1991, Odisha Panchayat Samiti Act, 1959 and Odisha Gram Panchayat Act, 1964 and Rules framed there under directs that ward-wise electoral roll of Juba Gram Panchayat under Belpada Block in Balangir District shall be prepared as per schedule detailed below.




